 - 9. Discuss and consider first reading of Ordinance No. 15-806 Dedicating an Alleyway Situated in Lots 7 and 9 of Block 13 of Daugherty's Addition to the City of Eastland to be Used as a Public Thoroughfare in Conjunction with a Portion of an Existing Alleyway


