Each request is evaluated and discussed by the West Texas Grant Committee and money is allocated as best it can.

At the Eastland County Friends of NRA Event, you'll meet Oil Men, 2nd Amendment Advocates, fire fighters, engineers, shopkeepers, police officers, teachers, military, and many more mainstream citizens working together to support an important cause in preserving our rights and heritage.
